1. Call meeting to order

6. Discuss options for Spot Check schedule changes for All-State Chorus

Joni motioned to keep spot checks in the morning and allow any school selected for spot checks, that is also involved in a football playoff game the night before, to do their spot check at 1:45pm.

George seconded the motion.

Brooks clarified that schools with All-State Chorus students involved in football playoff games the Thursday prior to All-State Chorus, and have a long distance to travel to the All-State Chorus site, will be permitted to arrive after lunch on the Friday of All-State Chorus. If any of those schools are selected for spot checks, they will do their spot check separately at 1:45pm.

The motion passed unanimously.

7. Consider changes to Spot Check school selection formula

The committee recommends that a subcommittee be formed to review quartet numbers and explore ways to structure the spot check selection process that would prevent schools from being selected for spot checks multiple years in a row.

8. Discuss concerns submitted by SD collegiate vocal professors pertaining to recruitment efforts of hired guest conductors of the All-State Chorus.

The committee discussed the concerns presented from the collegiate vocal professors. Brooks will verbally inform guest conductors that direct recruitment during the event is not permitted.

No motion was made on this agenda item.

9. Review changes to All-State Band audition requirements recommended by the ASB sub-committee.

The committee discussed the recommendations presented by the subcommittee. Recommendations for changes to the All-State Band audition process include eliminating the terms test, eliminating minor scales, rewriting major scales to include 2 octaves whenever possible, and to have students randomly select 2 scales for their audition. Scales would be divided into 2 groups; group 1 would contain scales with 0-4 sharps/flats, and group 2 would contain scales with 5-7 sharps/flats. The subcommittee also proposed using the solo literature list that is used by the NYSSMA, located at hickeys.com. The committee rejected the recommendations from the subcommittee. No motions were made on this agenda item.

10. Review proposals submitted by Harrisburg, Lyman and Howard school districts regarding recorded All-State Band auditions

The committee discussed the proposals regarding a format change for All-State Band auditions. Brooks expressed concerns about inherent inequities in the audition process due to auditions being held on 3 separate weekends. The committee does not feel that providing some students with an additional 2 weeks of preparation time gives those students a competitive advantage. The committee expressed concerns over recording quality affecting audition scores. Brooks discussed concerns with inclement weather and difficulties in rescheduling auditions if some need to be postponed due to weather. Factors in the discussion included safety in travel for students, directors, and judges, difficulties in rescheduling the charter plane, working around the teaching schedules of the judges, missed class time for students and directors, lack of substitute teachers in the state, ensuring that all students are auditioning in the same format (all live or all recorded), and ensuring that students audition for the same judges (ie.. all flutes in SD will be heard by 1 judge).

After much discussion, the committee rejected this proposal. No motion was made on this agenda item.

11. Review proposals submitted by Northwestern, Gregory, Hoven, Winner, Chamberlain, and Aberdeen Roncalli regarding a change to 2 weekends of All-State Band auditions, combining the schools from the Pierre, Watertown, and Aberdeen sites into one site in Huron.

The committee discussed the proposal to combine the Aberdeen, Pierre, and Watertown auditions into 1 site. Brooks presented the audition schedule for the combined site using audition numbers from those sites from the 2024 auditions. Brooks expressed concerns over judges being required to judge auditions from 8am-6pm at this site, as well as the Sioux Falls and Brandon sites. Brooks explained that some auditions could be moved to the Thursday night prior to the Friday auditions in order to lighten the audition numbers for Friday. Brooks expressed concerns over increased travel for schools using this option. Some schools would have auditions scheduled on Thursday night and on Friday which would cause those schools to travel 2 days in a row. This option would also increase the travel distance for many schools, requiring some schools to drive 3 or more hours to the audition site. Brooks also expressed concerns over logistics in holding auditions on a Friday at Lincoln High School due to the large student population at the school and the number of rooms needed for auditions and the terms test.

After much discussion, the committee rejected this proposal. No motion was made on this agenda item.

12. Organization of the Committee Starting in 2024-2025
George Dragoo, Class AA Band rep — West, has finished his term on the committee. The class AA Vocal rep (West) position is open. Nominations for both positions will be accepted via email to Brooks Bowman. Nominees will be placed on a ballot and directors will vote for new representatives.
